1. Data Controller Details

The Data Controller is responsible for the protection of personal data in accordance with the **General Data Protection Regulation (EU) 2016/679 – GDPR**, Act CXII of 2011 on the Right of Informational Self-Determination and Freedom of Information (Infotv.), and other relevant laws.

2. Categories of Personal Data Processed

- **Contact details:** name, e-mail address, phone number (e.g. in case of reservations or inquiries)
 - **Billing details:** name, address, tax number, payment information
 - **Technical data:** IP address, browser type, cookies, web analytics data
 - **Marketing data:** newsletter subscription, promotional consents

3. Purpose and Legal Basis of Data Processing

- **Reservations and communication:** performance of a contract and consent (GDPR Article 6(1)(b), (a))
 - **Billing and legal obligations:** compliance with accounting and tax regulations (GDPR Article 6(1)(c))
 - **Marketing and promotions:** based solely on consent (GDPR Article 6(1)(a))
 - **Website operation and security:** legitimate interest (GDPR Article 6(1)(f))

4. Data Retention Period

- **Reservation data:** until the reservation is completed, maximum 1 year
 - **Billing data:** 8 years (as required by accounting laws)
 - **Marketing data:** until consent is withdrawn
 - **Technical website data:** maximum 1 year (unless longer retention is necessary for legal claims)

5. Data Transfers

Your personal data may only be shared with the following third parties:

- **IT and hosting providers** (for website operation)
- **Accounting and tax advisors** (for compliance with legal obligations)
- **Marketing agencies** (only with your consent)

No data is transferred outside the **EU/EEA**.

6. Rights of Data Subjects

Under the GDPR, you have the following rights:

- **Right of access:** to obtain information on the processing of your personal data
- **Right to rectification:** to request correction of inaccurate or incomplete data
- **Right to erasure ("right to be forgotten"):** to request deletion where no legal basis exists for processing
- **Right to restriction of processing**
- **Right to object:** to processing based on legitimate interest
- **Right to data portability:** to receive your data in a structured, machine-readable format
- **Right to withdraw consent:** at any time for data processing based on consent (e.g. marketing)
